### Major General James L. Williams Commanding General, 4th Marine Division

Major General James Williams' is currently assigned as the Commanding General, 4th Marine Division since April 2007. His previous position was as the Assistant Division Commander, 2nd Marine Division and served during combat operations 2005-2006, at Camp Blue Diamond, Ar-Ramadi, Iraq, and earlier with I Marine Expeditionary Force as the Deputy Commanding General in Fallujah, Iraq. He also serves on the SecDef Reserve Force Policy Board.

Major General Williams was born in Bethlehem, Pennsylvania. His formative years were spent in Reading and Philadelphia, Pennsylvania. He received a B.S degree from Slippery Rock University, PA, in 1975. He reported to Officer Candidate School in January 1976, and received his commission in March 1976. He received Master's degrees from Georgetown University in Government and National Security Affairs in 1981, from Yale University in Hospital Management/Public Health in 1984, and from the U.S. Army War College in International Security Studies in 2000. Currently, he is in the process of working on his Master's Degree in Computer Engineering and Computer Science.

Upon completion of The Basic School, Quantico, VA, in 1976, he did a short tour with the Officer Selection Office in Pittsburgh, PA. He was subsequently assigned in 1976 to the 3rd Marine Division to serve with 3rd Battalion, 9th Marines serving as a Rifle Platoon Leader and the Super Squad Platoon.

Returning from overseas in January 1978, he reported to 2nd Force Troops (now 2nd Marine Logistics Group), as the Assistant Command Inspector. He was then assigned to 2nd Force Reconnaissance Company as a Force Recon Platoon Leader and deployed several times for NATO exercises. During this period he attended reconnaissance training schools.

In 1979, he was transferred to Marine Barracks, Washington, D.C. He was promoted to Captain in 1980. During this tour he served as Ceremonial Platoon Leader; White House Presidential Military Social Aide to Presidents Carter and Reagan; coach of the Barracks boxing team; Head,

The Basic School Correspondence Course, Marine Corps Institute; and attended graduate school at Georgetown University from 1979 to 1981. He completed the Amphibious Warfare Non-Resident Course in 1980.

In 1981, he was assigned to the Reserve component of the Marine Corps and was assigned to duty with the 14th Marines where he served with 2nd Battalion, 14th Marines, 4th Marine Division as a Forward Observer, Battery Executive Officer, Battery Commanding Officer, and Battalion Logistics Officer. While with the 14th Marines, in 1986, he was the recipient of the Outstanding Junior Marine Corps Reserve Officer Award presented by the Reserve Officers Association. He was promoted to Major in 1987. He also completed graduate school at Yale University during this period.

He was then assigned to the 4th Reconnaissance Battalion in 1988, where he served as the Battalion Operations and Training Officer, Battalion Diving Officer, and Executive Officer. During 1990-1991, the Battalion was called to duty for Operation Desert Shield/Storm. One reconnaissance company was assigned to lead the reconnaissance efforts for both the 1st and 2nd Divisions in their attacks on Iraq. The remainder of the Battalion was assigned to conduct counter-narcotics operations in CONUS and OCONUS. In 1991, he attended the Marine Corps Reserve Command and Staff College Course as a student.

In 1992, he completed school and was assigned to the 4th Marine Division as Assistant Operations Officer. In 1993, he completed the Air Command and Staff College Reserve Component Course. In October 1993, he was assigned as the Assistant G-6. He was promoted to Lieutenant Colonel in 1994. In 1995, he was assigned as Commanding Officer, 1st Battalion, 23rd Marines. In 1997, the battalion was assigned to the 1st Marine Regiment, 1st Marine Division for Kernal Blitz '97. He was selected in 1997, to attend the U.S. Army War College Distant Education Program. He was promoted to Colonel in 1998.

He was then selected and assigned to be the Deputy Commander, 1st Marine Expeditionary Force Augmentation Command Element (I MACE) in 2000. In 2000, he graduated from the U.S. Army War College. In 2002, while in this assignment he was assigned as the Deputy Director, Operations CJTF-180, conducting combat operations in Afghanistan for Operation Enduring Freedom. He was selected for promotion to Brigadier General 2003.

From 2003-2005 he served as the Commander, 1st Marine Expeditionary Force Augmentation Command Element (I MACE), during this period he served as the Acting Commanding General, I Marine Expeditionary Force at Camp Pendleton.

FOR SUPERIOR PERFORMANCE OF DUTIES WHILE SERVING AS COMBAT ENGINEER PLATOON COMMANDER, BATTALION LANDING TEAM 1ST BATTALION. 6<sup>TH</sup> MARINES, 24<sup>TH</sup> MARINE EXPEDITIONARY UNIT IN SUPPORT OF OPERATION ENDURING FREEDOM AND COMMANDING OFFICER, COMPANY C. 2D COMBAT ENGINEER BATTALION FROM MARCH 2008 TO APRIL 2009. UNDER HIS LEADERSHIP, CAPTAIN BAHLAU AND HIS PLATOON SUPERBLY EXECUTED MOBILITY. COUNTER MOBILITY AND SURVIVABILITY MISSIONS IN AUSTERE CONDITIONS AND WHILE UNDER ENEMY OBSERVATION AND FIRE. ON 14 MAY 2008. HE LED A JOINT ENGINEER TASK FORCE TO INSTALL A BRIDGE AND-REESTABLISH A SUPPLY ROUTE TO A COMPANY IN PURSUIT OF ENEMY FORCES. HIS BOLD ACTION ALLOWED THE BATTALION LANDING TEAM TO MAINTAIN MOMENTUM AND BREACH THE ENEMY DEFENSIVE BELT. HIS EXPERIENCE AND LEADERSHIP WERE INSTRUMENTAL IN TRAINING AND DEPLOYING IN SUPPORT OF OPERATION IRAQI FREEDOM. CAPTAIN BAHLAU'S LEADERSHIP AND COURAGE UNDER FIRE REFLECTED GREAT CREDIT UPON HIMSELF AND UPHELD THE HIGHEST TRADITIONS OF THE MARINE CORPS AND THE UNITED STATES NAVAL SERVICE.

# STAFF SERGEANT MIGUEL A.CIRA UNITED STATES MARINE CORPS

#### FOR SERVICE SET FORTH IN THE FOLLOWING:

FOR MERITORIOUS ACHEIVEMENT WHILE SERVING AS PLATOON GUIDE, 1ST PLATOON, COMPANY B. 1ST COMBAT ENGINEER BATTALION, REGIMENTAL COMBAT TEAMS 5 AND 8. I AND II MARINE EXPEDITIONARY FORCE (FWD) FROM APRIL 2008 TO MARCH 2009 IN SUPPORT OF OPERATION IRAQI FREEDOM. AFTER CONTRIBUTING TO A RIGOROUS PRE-DEPLOYMENT WORKUP, SSGT CIRA DEPLOYED WITH THE PLATOONS ADVANCED PARTY AND IMMEDIATELY BEGAN CONDUCTING ENGINEER ASSESSMENT, CONSTRUCTION PLANNING, AND PREPARING EQUIPMENT FOR THE PLATOONS ARRIVAL. HIS HARD WORK AND DEDICATION TO MISSION ACCOMPLISHMENT WERE INSTRUMENTAL AS THE PLATOON CONDUCTED ITS FIRST COMBAT ENGINEERING OPERATION JUST 4 DAYS AFTER ARRIVING IN IRAQ, SETTING THE STANDARD OF TIMELINESS AND EFFICIENCY WHICH WOULD CARRY THE PLATOON THROUGH THE FAST-PACED DEPLOYMENT. HIS PERFORMANCE DURING THE PLATOONS FIRST OPERATION LED TO HIS APPOINTMENT AS THE LOGISTICAL COORDINATION ELEMENT BETWEEN THE PLATOON AND THE TASK FORCE STAFF. REGULARLY SEPARATED FROM THE PLATOON BY HUNDREDS OF MILES, SSGT CIRA COORDINATED SUPPORT FOR THE PLATOON AND FACILITATED MISSION ACCOMPLISHMENT, OFTEN UNDER STRICT TIMELINES. HIS WORK ETHIC AND PROFICIENCY WERE A DRIVING FORCE IN EACH OF THE PLATOON& MANY ACCOMPLISHMENTS. INCLUDING MAJOR FORCE PROTECTION IMPROVEMENTS TO 6 COMBAT OUTPOSTS WHICH FACILITATED THE RAPID REALIGNMENT OF FORCES IN AREA OF OPERATIONS WEST TO A POSTURE OF OPERATIONAL OVERWATCH. SSGT CIRA ALSO DEDICATED HIS TIME TO DEVELOPING AND MENTORING HIS MARINES, CONDUCTING REGULAR PT AND MARTIAL ARTS TRAINING WHICH STRENGTHENED THE UNIT& CAMARADERIE. SSGT CIRAS ENTHUSIASM, PROFESSIONALISM, AND UNWAVERING DEVOTION TO DUTY REFLECTED GREAT CREDIT UPON HIM AND WERE IN KEEPING WITH THE HIGHEST TRADITIONS OF THE MARINE CORPS AND THE UNITED STATES NAVAL SERVICE.

#### COMBAT ENGINEER NONCOMMISSIONED OFFICER OF THE YEAR AWARD TO

### SERGEANT DAVID J.LANG UNITED STATES MARINE CORPS

#### FOR SERVICE SET FORTH IN THE FOLLOWING:

FOR MERITORIOUS ACHIEVEMENT WHILE SERVING AS SQUAD LEADER, COMBAT ENGINEER PLATOON, SECOND BATTALION, SEVENTH MARINES, MARINE CORPS FORCES CENTRAL COMMAND (FORWARD), FROM 27 MARCH, 2008 TO 1 DECEMBER. 2008 IN SUPPORT OF OPERATION ENDURING FREEDOM. SERGEANT LANG& SQUAD SERVED IN DIRECT SUPPORT OF COMPANY F IN THE NOW ZAD DISTRICT CENTER OF HELMAND PROVINCE, AFGHANISTAN, HIS SQUAD SUPPORTED OVER 400 COMBAT PATROLS AND SERGEANT LANG PERSONALLY SUPPORTED OVER 50 COMBAT PATROLS AND 9 COMPANY SIZED DELIBERATE OFFENSIVE OPERATIONS, DURING A COMPANY RAID ON AN ENEMY TRENCH NETWORK ON 15 JUNE, SERGEANT LANG EMPLOYED THE APOBS UNDER INTENSE ENEMY MACHINE GUN, SMALL ARMS AND RPG FIRE TO CLEAR IEDS FOR THE ASSAULT FORCE. DURING A RAID ON A KNOWN ENEMY STRONG POINT ON 23 JUNE, SERGEANT LANG SWEPT FORWARD OF THE COMPANY, PROVIDING SAFE PASSAGE THROUGH AN AREA HEAVILY LADEN WITH IEDS. WHEN THE ASSAULT ELEMENT BECAME FIXED AS THEY RECEIVED INTENSE FIRE. HE FIRST ENGAGED AND DIRECTED FIRE ONTO THE ENEMY, AND THEN EMPLOYED AN URBAN BREACHING CHARGE TO CREATE AN ALTERNATE ROUTE OUT OF THE KILL ZONE. ON 8 JULY. SERGEANT LANG AGAIN SWEPT FORWARD OF THE COMPANY, AND ALSO PROVIDED MOBILITY AND COMBAT POWER BY DIRECTING THE ARMORED COMBAT EARTHMOVER. (ACE) IN THE DESTRUCTION OF MULTIPLE ENEMY FIGHTERS AND FIGHTING POSITIONS. AND IN THE BREACHING OF NUMEROUS COMPOUND WALLS. SERGEANT LANG ALSO PROVIDED CRITICAL MOBILITY BY ENGINEERING A METHOD TO EMPLOY THE MINE CLEARING LINE CHARGE (MICLIC) FROM THE OPEN FLATBED OF AN MTVR. AS HIS COMPANY LACKED CONVENTIONAL METHODS. SERGEANT LANG& INITIATIVE. PERSEVERANCE. AND TOTAL DEDICATION TO DUTY REFLECTED CREDIT UPON HIM AND WERE IN KEEPING WITH THE HIGHEST TRADITIONS OF THE MARINE CORPS AND THE UNITED STATES NAVAL SERVICE.

# CORPORAL RICHARD J.LOWERY UNITED STATES MARINE CORPS

#### FOR SERVICE SET FORTH IN THE FOLLOWING:

FOR EXCEPTIONAL PERFORMANCE OF DUTIES WHILE ASSIGNED TO 2D PLATOON, ALPHA COMPANY, 2D COMBAT ENGINEER BATTALION, FROM APRIL 2008 THROUGH MARCH 2009, IN SUPPORT OF OPERATION ENDURING FREEDOM SOUTHERN AFGHANISTAN WHILE ATTACHED TO 3D BATTALION 8TH MARINES (REINFORCED), SPECIAL PURPOSE MARINE AIR GROUND TASK FORCE - AFGHANISTAN. LANCE CORPORAL LOWERY DEMONSTRATES A SIGNIFICANT KNOWLEDGE OF COMBAT ENGINEERING AND ALWAYS EXERCISES A STRONG WORK ETHIC IN THE COMPLETION OF HIS TASKS. DURING THE COMBAT TOUR, LANCE CORPORAL LOWERY FIRST SUPPORTED OPERATIONS IN DELARAM, WHERE HE ASSISTED IN THE CONSTRUCTION OF TWO LARGE ENTRY CONTROL POINTS IN ADDITION TO PROVIDING MOBILITY SUPPORT FOR 20 PATROLS. HE THEN PARTICIPATED IN COUNTER IMPROVISED EXPLOSIVE DEVICE OPERATIONS ALONG ROUTE 515 IN FARAH PROVINCE. WHICH ENABLED FREEDOM OF MOVEMENT AND PERSISTENT PRESENCE FOR US FORCES IN THE REGION. WHILE IN NOW ZAD, IN SUPPORT OF COMPANY L AND THE SCOUT SNIPER PLATOON, LANCE CORPORAL LOWERY SWEPT FOR PRESSURE PLATE IEDS WITH A MINE DETECTOR TO ALLOW FREEDOM OF MOVEMENT OF MARINE PATROLS. HE CONDUCTED THREE MISSIONS OF THIS NATURE WHEN AN IMPROVISED EXPLOSIVE DEVICE DETONATED: KILLING TWO COMBAT ENGINEER NONCOMMISSIONED OFFICERS WITHIN FEET OF HIM. LANCE CORPORAL LOWERY WAS KNOCKED UNCONCIOUS FROM THE BLAST AND SUSTAINED A GRADE III CONCUSSION. AFTER REGAINING CONCIOUSNESS HE ASSISTED IN THE RECOVERY OF THE TWO ENGINEERS WHO WERE KILLED. WHILE RECOVERING FROM HIS INJURIES. HE CONTINUED TO BE A VALUABLE ASSET TO THE PLATOON BY TRAINING AND MENTORING OTHER MARINES ON ENEMY AND FRIENDLY TACTICS, TECHNIQUE AND PROCEDURES. LANCE CORPORAL LOWERY & EXEMPLARY CONDUCT AND ENTHUSIASM FOR THE ENGINEER MISSIONS ASSIGNED TO HIM MARK HIM AS A SUPERB COMBAT ENGINEER AND WAS IN KEEPING WITH THE HIGHEST TRADITIONS OF THE MARINE CORPS AND THE UNITED STATES NAVAL SERVICE.

FOR EXCEPTIONAL PERFORMANCE OF DUTIES WHILE ASSIGNED TO ENGINEER COMPANY, COMBAT LOGISTICS BATTALION-6, 1ST MARINE LOGISTICS GROUP (FORWARD), AND SUPPORT COMPANY, 8TH ENGINEER SUPPORT BATTALION, 2D MARINE LOGISTICS GROUP, II MARINE EXPEDITIONARY FORCE, FROM 1 APRIL 2008 TO 31 MARCH 2009. DURING THIS PERIOD, CHIEF WARRANT OFFICER 2 CLERK PERFORMED HIS DUTIES IN AN EXEMPLARY AND HIGHLY PROFESSIONAL MANNER. CHIEF WARRANT OFFICER 2 CLERK& COMMITMENT TO THE MISSION AND HIS MARINES WAS EVIDENT IN HIS TIRELESS EFFORTS THROUGHOUT THE YEAR. HIS TECHNICAL AND TACTICAL EXPERTISE WERE INSTRUMENTAL IN SUPPORT OF VITAL ENGINEER MISSIONS TO INCLUDE THE REDESIGN AND CONSTRUCTION OF RUTBAH& TRAFFIC CONTROL POINT 2. 
